Information about the Library

- The building is located in McHenry County and the library district covers areas in McHenry County and a small portion of Lake County, including most of the Village of Cary, the Village of Trout Valley, unincorporated Cary, portions of Prairie Grove, Oakwood Hills and parts of unincorporated Crystal Lake, including Burton's Bridge.
- The population of the Library District is 27,256 as of the 2020 Census.
- The Library currently has 43 employees (not including Board members).
- Our library's annual budget for FY 23/24 is \$2,464,709.
- Our library's Equalized Assessed Valuation (EAV) for 2023 is \$950,894,821.

Core Programs or Services Offered by the Library

Our Library offers the following core programs:

- Book-An-Expert
- Circulation of Library materials
- Collection boxes: Local organizations may have a collection box in the lobby for donations of non-cash items.
- Community information
- Computer Literacy
- Copy/Print/Fax services
- Homebound delivery: Scheduled delivery for those who cannot get to the Library.
- Homeschool outreach: Materials available to support homeschoolers with their curriculum.
- Job seekers help
- Interlibrary Loan: Patrons may request items from libraries nationwide.
- Library of Things: Collection of non-traditional items to check out.
- Meeting rooms: A meeting room that is available to the public that seats up to 100 and can be split to seat 45 or 55.
- Memory kits: Kits funded by the Rotary for those who have a loved one in need of memory stimulation.
- Online services: Digital reference and collections available from anywhere.
- Programs: A wide variety of programs for all ages.
- Reference services
- School outreach: Fourth graders visit the Library in the fall to learn what resources the Library has and how to use them.
- Seed Library: Seeds available in the spring for library patrons to plant at home.
- Senior citizen outreach: Visit local senior housing and assisted living facilities.
- Story times: Several sessions per week for various age groups.
- Study rooms: Available for groups up-to 2, 6, or 8.
- Tax forms: Popular tax forms and instructions available to copy.

Our Library could offer:

- Book bike to have at community events.
- Fix-it day or month.
- Lockers at the train station.
- Summer camp story time.

What Have We Done Well?

- The Library passed a referendum to become a district in 1995.
- A new 20,000 sq. ft. building was donated to the Library District in 1999.
- The Library received a \$100,000 gift in 2000 to be used for building purposes and it was used towards the addition of a drive-up drop and window in 2016.
- In 2016, the Library added three study rooms, a conference room and additional program space by reconfiguring space within the building.
- In 2016, the Library added an elevator to make the basement accessible and to add collaborative work space for library employees.
- Air cleaners were added to the HVAC system in 2021 to reduce the spreading of germs in the building.
- The Library passed an annexation referendum in 2007 to add additional properties to the district.
- The Library began working with an asset management company to increase return on investments.
- We have collaborated well with other libraries through groups that include the libraries in the North Suburban area and in McHenry County.
- The library continually offers training opportunities to employees because a knowledgeable staff benefits the public.
- As a member of our local ICG (Intergovernmental Coordinating Group) we work with other governmental entities in our community to share information, make each other aware of our projects and programs and share resources when possible.

What Inefficiencies Did We Identify?

- Libraries are efficient, because they have to be.
- The library's board and employees continuously review inefficiencies and act upon them when they are identified.

What Can We Do Better or More Efficiently?

- We could make the acre of land behind the Library more usable for programming, i.e., pave part of it and surround with benches.
- Consider alternative energy.
- Review employee benefits and how to make them better.
- We can look at our statistics on a regular basis and try to improve library use based any inefficiencies.
